The Seller accepts a non-refundable deposit of \$250.00 (to be give or mailed with agreement to Seller) toward the purchase of the puppy identified below. Buyers who make a deposit will be able to hold a puppy until purchase time. When puppies are born, any deposit money that was paid will be return to Buyer (or saved until the next litter) if not enough puppies are born in the litter. Buyer must let Seller know what sex of puppy they want at the time deposit is paid to Seller. Picks of puppies will come in order of when deposits are paid to Seller. Buyer must pick out puppy by 6 weeks of age either by a visit or online. Seller reserves the right for first picks of litter at anytime until day of final payment and pick up of puppy. Seller holds the right to return deposits to Buyer if at any time she feels this will not be a good placement for the puppy. Deposit money goes toward the final price of puppy. Payments are taken by cash, paypal, cashier check or money order only. Please make out any checks to Grams Golden Retrievers.

The purchase price is \$____.00. Additionally, sales tax of \$____.00 (7% Iowa State and local taxes) is to be paid at the time of delivery of puppy to Buyer. Sales tax will not be added if puppy is shipped out of the state of Iowa. A shipping cost of \$400.00 by the Buyer will be added to price to help cover shipping expenses and handling. Buyer must pay for puppy and shipping at least 3 days before shipment of puppy to Buyer. Shipping of puppy can be anywhere in the United States but shipping to other countries is not allowed.

TERMS AND CONDITIONS

The Sellers represent:

That the above puppy has been examined by a licensed Veterinarian and was found to be in good health. That this puppy is being sold on a **limited** registration only. This means that puppy is not being sold for the purpose of breeding. That this puppy will not be listed with any other registry in order to be used for breeding.

Limited Registration means that the dog is registered AKC but no litters produced by the dog are eligible for registration. Dog with limited registration may **not** be entered in breed competition at Dog Shows but may compete in all other AKC events such as: obedience trials, agility completion and any other AKC event other than show.

That reasonable precautions have been taken to prevent this puppy from acquiring hereditary defects of the hips, elbows, eyes and heart, by having parents screened and certified before producing puppies. However due to unknown hereditary and environmental causes of such defects, no guarantee will be given against them.

THE FOLLOWING APPLIES ONLY TO THE ORIGINAL BUYER(S):

The buyer(s) agree(s).

That this puppy will be examined by a licensed Veterinarian within 96 hours of receipt. If the puppy is returned due to illness, a verified letter from the Veterinarian is required. This includes death or illness from any health condition deemed present prior to removal of puppy from **Grams Golden Retrievers** premises. Any condition that is related to environment changes, stress due to adjusting to new home and/or change of diet that causes diarrhea, any parasites, worms, etc., (conditions such as Coccidia or Giardia or various types of worms, as many times these are unavoidable in a kennel environment) is also excluded.

That said dog will be given proper medical care including, but not limited to vaccinations and annual boosters, regular deworming, adequate and proper shade and housing in a fenced yard or kennel. That the buyer will groom, train and care for this dog in a manner consistent with high quality animal husbandry practices and those endorsed by the Breeder and the Golden Retriever Club of America. That this puppy will be fed a high quality large breed puppy food for the first 9 to 12 months of age to prevent over growth of bone structure with could lead to hip, elbow or any other joint disease.

That this dog will not be used for any purpose of research or vivisection and shall not be sold or given to any wholesale establishment, chain store, catalog sales house, pet store or puppy mill.
